

# Model Release Contract – TFP

This contract is a non-commercial agreement in which the Model, to gain modeling experience, agrees to exchange modeling time in order to receive processed photographs with the following specifications:

The delivery of the above photographs will be 14 days after the date this contract is signed by both Model and Photographer. The delivery of the photograph fulfills all the obligations of the Photographer. The copyright and all other lawful rights to the Photos solely belong to the Photographer and his/her assigns.

The Model may use the Photos in his/her possession to promote his/her modeling business, including the use of the Photos in portfolios, exhibitions, websites, contests, and advertising. However, the Model will not sell or transfer publication rights of the Photos without the consent of the Photographer.

The Photographer may use the Photos to promote his/her photography business, including the use of the Photos in portfolios, exhibitions, websites, contests, and advertising. However, the photographer will not sell or transfer publication rights of the Photos without the consent of the Model.

The Model will acknowledge the Photographer as the author of the Photos and will communicate this to third parties that are involved in his/her modeling business. The Photos shall not be altered or distorted when used to promote the Model's business. Any copyright notice or watermark embedded in the Photo must not be removed or changed.

The Model releases the Photographer and/or his/her assigns from any liability due to the publication of the Photos unless it can be undoubtedly proven that the use of the Photos was malicious and intended to publicly present the Model in an unfavorable light.

The Model confirms that all poses, positions, and situations presented in the Photos were entered into willingly, without force or coercion. The Model also states that he/she did not breach any prior contracts when this contract was formed.

Both the Model and the Photographer have read and agreed to the foregoing terms and conditions.
